Online Applications are invited from eligible Indian citizens (Male & Female) (including subject of **Nepal or Bhutan**) for filling up the vacancies of Constable (Kitchen Services), in Group ‘C’ Non-Gazetted (Non-Ministerial) on temporary basis likely to be permanent in ITBPF. Selected candidates will be liable to serve anywhere in India or abroad. On appointment, the candidates shall be governed by the ITBPF Act, 1992 and ITBPF Rules, 1994 and other Rules applicable from time to time. Applications from candidates will be accepted through **ONLINE MODE** only. No other mode for submission of application is allowed. **ONLINE APPLICATION MODE WILL BE OPENED W.E.F. 2<sup>ND</sup> SEPTEMBER, 2024(02/09/2024) AT 00:01 AM AND WILL BE CLOSED ON 1<sup>ST</sup> OCTOBER, 2024 (01/10/2024) AT 11:59 PM.** The applicants are advised to check their eligibility before applying so as to avoid disappointment at a later stage.

- (1) The vacancies are tentative and may increase or decrease without any notice. Any change in the number of vacancies will be intimated through ITBPF Recruitment website i.e. <https://recruitment.itbpolice.nic.in>.
- (2) 10% of the vacancies are reserved for Ex-Servicemen. In case, vacancy reserved for Ex-servicemen remains unfilled due to non-availability of eligible or qualified candidates, the same shall be filled by non Ex-serviceman candidates of respective categories.
- (3) ITBPF reserves the right to make changes in sequence of the recruitment procedure after publication of this advertisement. ITBPF also reserves the right to cancel or postpone the recruitment at any stage due to administrative reasons.
- (4) As per MHA guidelines, if a situation so arises wherein, the women candidates in the horizontal compartmentalized reservation in any of the vertical reservation categories are not available, then the posts shall be filled up from amongst the male candidates from the concerned vertical reservation categories.



(5) Candidates claiming **OBC (NCL)** status may note that certificate on Non-Creamy Layer status should be based on the income earned during three previous financial years (i.e. 2023-24, 2022-23 and 2021-22) and must ensure that he/she should be in possession of caste/community and Non-Creamy Layer (NCL) certificate before the closing date for submission of online applications. i.e. **1<sup>st</sup> October, 2024 (01/10/2024)**.

- ii) Certificates for claiming **SC/ ST/ OBC (NCL)/ EWS** status should be issued before the closing date for receipt of online applications.
- iii) Candidates claiming **Economically Weaker Sections (EWS)** status may note that their certificate of Income & Assets should be based on the financial year prior to the year of application and should be in possession before the closing date for submission of online applications, i.e. **1<sup>st</sup> October, 2024 (01/10/2024)**.
- iv) Candidates claiming **OBC (NCL)** status may note that certificate on non-creamy layer status should be based on the income earned during three previous financial years (i.e. 2023-24, 2022-23 and 2021-22) and should be in possession before the closing date of submission of online applications, i.e. **1<sup>st</sup> October, 2024 (01/10/2024)**.
- v) Candidates who wish to be considered against reserved vacancies or seeking age relaxation must submit requisite certificate issued by the competent authority, in the prescribed format when such certificates are sought by the Recruitment Board. <p>(i) A colour blind person will not be eligible for appointment. 5. **HOW TO APPLY AND BY WHICH DATE:-**

a)	Eligible and interested candidates need to apply online through ITBPF website <a href="https://recruitment.itbpolice.nic.in">https://recruitment.itbpolice.nic.in</a> . Candidates are advised to fill the application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to submit online only, application received offline shall not be considered <b>and will be rejected summarily.</b>
b)	Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.
c)	<b><u>APPLICATION FEE &amp; MODE OF PAYMENT</u></b> – Male candidates belonging to General (UR), OBC and EWS category applying for this recruitment will have to pay <b>Rs. 100/- (Rupees one hundred only)</b> as application fee through online payment gateway system on <a href="https://recruitment.itbpolice.nic.in">https://recruitment.itbpolice.nic.in</a> . Application received with any other mode of fee payment will be summarily rejected. <b>Candidates belonging to Scheduled Caste, Scheduled Tribe, Females and Ex-servicemen are exempted from paying the fee.</b>  <b>Note:-</b> i) Fee once paid will not be refunded under any circumstances. ii) Fee paid by modes other than online mode will not be accepted and the applications of such candidate will be rejected forthright. Besides above, the payment made in such cases shall stand forfeited.
d)	Candidates working in Central/State Government/ Autonomous/ Statutory Bodies/ Public Sector Undertaking etc. applied to the post are required to furnish “ <b>No Objection Certificate</b> ” in original as per <b>Annexure-VI</b> issued by the employer at the time of verification of documents. The candidature of candidates who fail to submit “ <b>No Objection Certificate</b> ” at the time of documentation shall be summarily rejected.

6. **SELECTION PROCESS:-**

- a) Admit Cards to the candidates will be issued online mentioning the date and venue of recruitment test. Candidature of candidates who are issued online admit cards will remain provisional till they are finally selected and submit all related documents/certificates in original and in prescribed format at the stage of verification of original documents.
- b) Candidates are required to bring a clear & legible print out of their online application form & admit card; else they will not be permitted to enter the venue of Physical Efficiency Test (PET) & Physical Standard Test (PST).

**Note:-**

- (i) Before start of PET & PST, the candidates will undergo thorough verification of identity including Biometric capture.
  - (ii) Biometric identification of candidates can also be verified at any stage of recruitment.
  - (iii) It is candidate's responsibility to check before hand that the biometric machines are able to capture the fingerprint image. In case, if the biometric machine is not able to capture the fingerprint image due to Mehndi, wax, etc. then, the candidate will not be allowed to appear in the examination.
  - (iv) Failure in biometric verification at any stage will lead to cancellation of candidature.

Candidates have to qualify each event of PET, those who do not qualify shall be eliminated.</p> <p>(iii) On reporting of female candidates for Physical Efficiency Test (PET) &amp; Physical Standard Test (PST), a self declaration indicating about her pregnancy status shall be submitted. In case, if she declares that she is not pregnant then, she may be allowed to participate in the PET/PST. In case of false declaration, all the risk for undergoing PET/PST will be of her own.</p> <p>(iv) If, the female candidate declares that she is pregnant before PET/PST, then a confirmatory pregnancy test to be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she may be declared temporary unfit and her appointment shall be held in abeyance until the confinement is over. However, female candidate who are declared temporary unfit will require to appear and qualify in remaining stages of recruitment i.e. PST, Written Examination, Documentation and Medical Examination. The vacancy against which a women candidate was selected will be kept reserved for her. She will be re-examined for PET/PST six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. 

v) Candidates are not permitted to use mobile phone, calculators or any other electronic/electrical device. Possession of these items, whether in use or not, will be considered as “**use of unfair means**” in the examination and appropriate action will be taken against such candidates.

	<p>vi) Candidates found copying or using any unfair means should be disqualified and debarred from further test. On the basis of merit, the candidates shall be shortlisted for verification of original documents (Documentation) and Detailed Medical Examination (DME) as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of Detailed Medical Examination (DME) and Review Medical Examination (RME) determined on the basis of past experience. However, <b>there shall be no reserve list.</b></p> <p>(ii) SC, ST, OBC (NCL) &amp; EWS candidates who are selected on their own merit without relaxed standards will not be adjusted against the reserved share of vacancies. Such SC, ST, OBC (NCL) &amp; EWS candidates shall be accommodated against the General vacancies as per their position in overall merit list. 

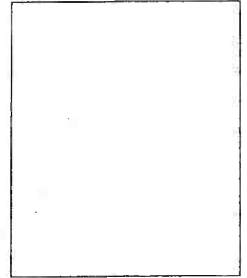
